

CHICKEN COOP BUILDING REQUIREMENTS

Chicken coops are defined by the City of West Bend Zoning Code section 17.44. Construction of a chicken coop follow the same requirements of the State of Wisconsin Uniform Dwelling Code. (SPS320-325) This code is available online at: http://dsps.wi.gov/sb/SB-DivCodesListing.html.

The maximum size of an accessory building for properties zoned residential is 720 square feet. If there are several out buildings on the parcel, the total may not exceed 720 square feet. The principal use of the property where a chicken coop and yards may be permitted is limited to single-family dwellings and duplexes within single-family or two-family zoned property. The chicken coop must be water-proof, rodent-proof, predator-proof and enclosed in a fenced-in area.

Chicken coops must be placed in the <u>rear yard</u> and have a minimum setback of 5 feet from the lot line. No coop or run shall be placed within <u>25 feet</u> of any separate residential or business structure on an adjacent lot. Lot markers and property lot lines must be visible at the time of inspection. The maximum height is 18 feet. Enclosures for chicken runs may be comprised of welded wire or chicken wire material but not be part of a residential fence within the property.


In order to obtain your permit you must provide a current plat of survey showing the lot lines and proposed/existing buildings on the property in relation to each other. An accessory structure may not be constructed in an easement. It shall be the owner's responsibility to verify that keeping chickens and chicken coops are permitted uses in any deed restrictions or covenants applicable to the subject property.




Submit the following to Building Inspection for Review and Processing:

- Current plat of survey showing property lines, easements, existing buildings, & the coop and fence proposed locations.
- 2 sets complete plans of coop & detail of fencing for run
- Completed Permit Applications
- Building Inspection Fees: \$ 0.35 per sq. ft. Building Permit \$25.00 Plan Review \$75.00 Zoning Permit >100sq.ft.
- Finance Department Fee: \$50.00 Annual License

ORDINANCE 2823 2018-2019 COMMON COUNCIL

Discussion on Amending Section 9.07 and Creating Section 9.075 and 12.175 of the Municipal Code Regarding Keeping of Chickens in the City

The Common Council of the City of West Bend do ordain as follows:

SECTION ONE. Section 9.07 is amended to read as follows:

9 07 ANIMALS OR SPECIES PROHIBITED WITHIN THE CITY.

(1) Keeping of Fowl Prohibited. Except as provided in Section 9.075, no person shall keep, raise or have in his possession any live fowl within the City, erect or maintain and use on any lot or parcel of land within the City any run, coop, structure or other building for the purpose of keeping or housing any type of fowl, including, but not limited to, chickens, geese, ducks, turkeys, pheasants or guinea hens, except, however, the keeping of racing or show pigeons.

SECTION TWO. Section 9.075 is created to read as follows:

Section 9.075 KEEPING OF CHICKENS.

- (a) No person shall keep or harbor any chickens or build, erect or maintain and use any chicken coop or run within the City without registering the name and address of the owner, the number of chickens, and paying the requisite license fee pursuant to Section 12.175.
- (b) Chickens must be contained within a coop or enclosed chicken run and may not be allowed to roam at large within or beyond the property.
- (c) Prior to issuance of a site license for the keeping of chickens, the owners of adjoining and surrounding properties shall be notified by the City Treasurer of the pending license request.
- (d) All chicken coops and runs wherein any chickens are contained shall be kept in a clean, sanitary condition and free from all objectionable odor or vermin.
- (e) Chicken coops and runs under this section shall be limited to the keeping of up to a total of four chickens per property, and shall be subject to the following conditions:
 - 1. The principal use of the property where a chicken coop and yards may be permitted is limited to single-family dwellings and duplexes within single-

- family or two-family zoned property.
- 2. No person shall keep any rooster.
- 3. No person shall slaughter any chickens.
- 4. Chickens shall be kept in a water-proof, rodent-proof and predator-proof coop in a fenced-in area.
- 5. Coops shall be considered accessory structures under Chapter 17 and shall be subject to all requirements of that Chapter. Coops and runs shall be placed in rear yards and shall have a minimum setback of 5 feet. No coop or run shall be placed within 25 feet of any separate residential or business structure on an adjacent lot.
- 6. Enclosures for chicken runs maybe comprised of welded wire or chicken wire material but may not be part of a residential fence within the property.
- 7. It shall be property owner's responsibility to verify that keeping chickens and chicken coops are permitted uses in any deed restrictions or covenants applicable to the subject property.

SECTION THREE. Section 12.175 is created to read as follows:

- (a) LICENSE REQUIRED. It shall be unlawful for any person in the City to own, harbor or keep chickens without complying with the provisions of this Section and Section 9.075.
- (b) LICENSE FEES. The yearly license fee for chickens shall be \$50 per site license
- (c) LATE FEES. The City Treasurer shall assess and collect a late fee of \$5 from every owner of a chicken if the owner failed to obtain a license prior to April 1 of each year or prior to acquiring ownership of a chicken.



Section 9.075 Keeping of Chickens

- No person shall keep or harbor any chickens or build, erect or maintain and use any chicken coop or run within the City without
 registering the name and address of the owner, the number of chickens, and paying the requisite license fee pursuant to Section 12.175.
- Chickens must be contained within a coop or enclosed chicken run and may not be allowed to roam at large within or beyond the
 property.
- Prior to issuance of a site license for the keeping of chickens, the owners of adjoining and surrounding properties shall be notified by the City Treasurer of the pending license request.
- All chicken coops and runs wherein any chickens are contained shall be kept in a clean, sanitary condition and free from all objectionable odor or vermin.
- Chicken coops and runs under this section shall be limited to the keeping of **up to a total of four chickens per property**, and shall be subject to the following conditions:
 - (1) Limited to single-family dwellings and duplexes within single family or two-family zoned property.
 - (2) No Roosters
 - (3) No person shall slaughter any chickens.
 - (4) Chickens shall be kept in a water-proof, rodent-proof and predator-proof coop in a fenced-in area.
 - (5) Coops shall be considered accessory structures under Chapter 17 and shall be subject to all requirements of that Chapter. Coops and runs shall be placed in rear yards and shall have a minimum setback of 5 feet. No coop or run shall be placed within 25 feet of any separate residential or business structure on an adjacent lot.
 - (6) Enclosures for chicken runs maybe comprised of welded wire or chicken wire material but may not be part of a residential fence within the property.
 - (7) It shall be the property owner's responsibility to verify that keeping chickens and chicken coops are permitted uses in any deed restrictions or covenants applicable to the subject property.

Noncompliance of Sections 9.075/12.175 could result in a citation.
